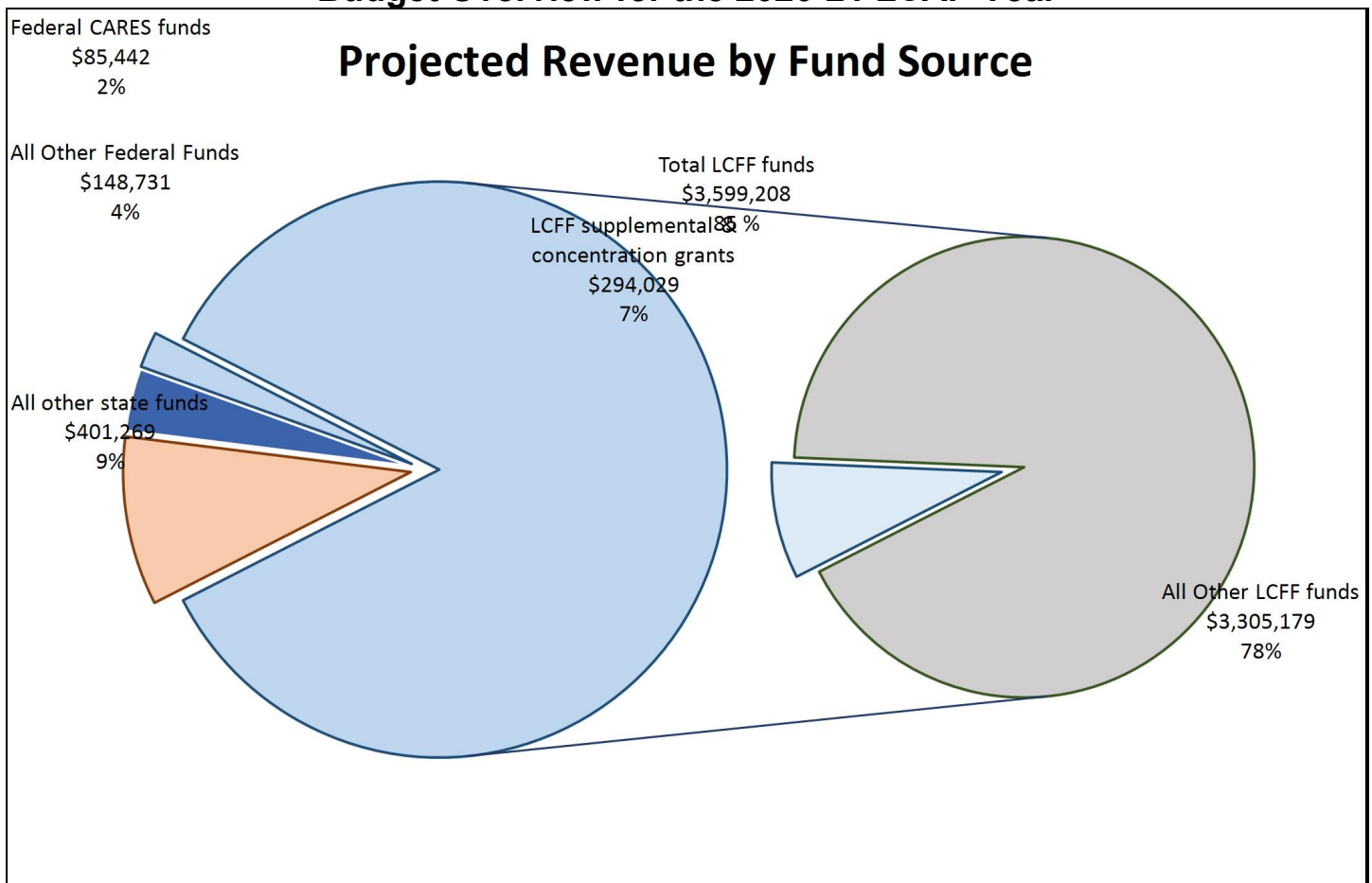

School districts receive funding from different sources: state funds under the Local Control Funding Formula (LCFF), other state funds, local funds, and federal funds. LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).

Budget Overview for the 2020-21 LCAP Year

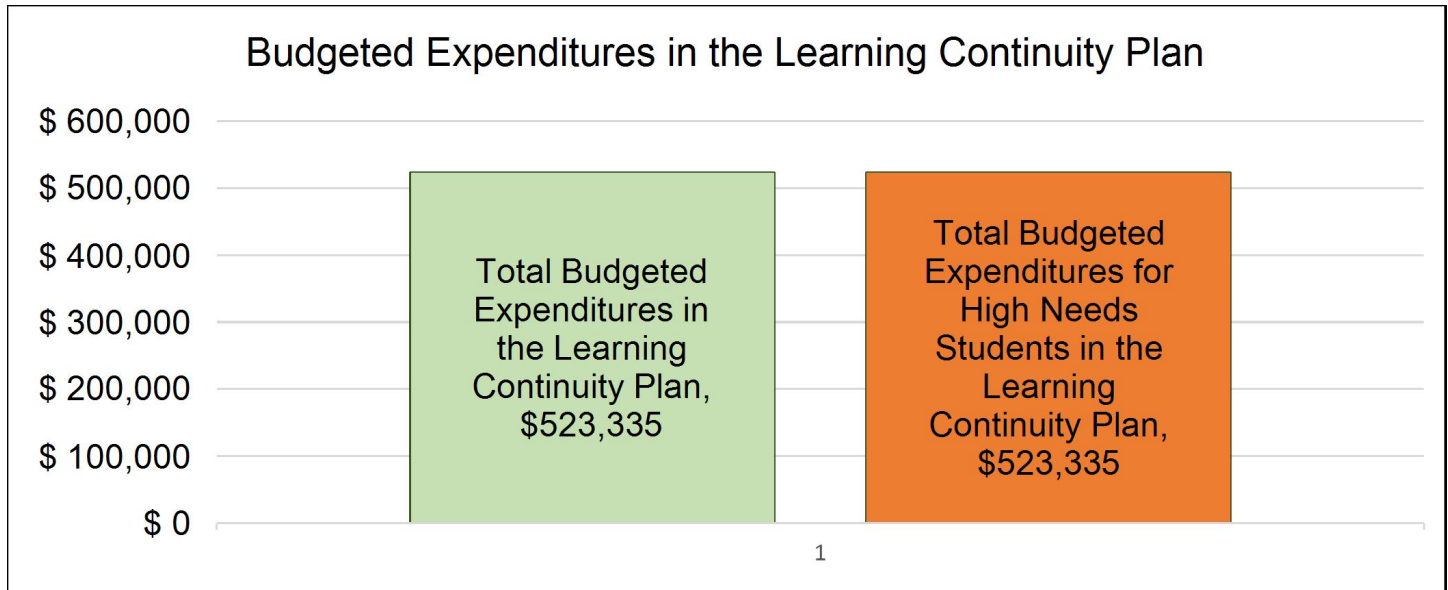


This chart shows the total general purpose revenue New Day Academy expects to receive in the coming year from all sources.

The total revenue projected for New Day Academy is \$4,234,650, of which \$3,599,208 is Local Control Funding Formula (LCFF), \$401,269 is other state funds, \$0 is local funds, and \$234,173 is federal funds. Of the \$234,173 in federal funds, \$85,442 are federal CARES Act funds. Of the \$3,599,208 in LCFF Funds, \$294,029 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

For the 2020-21 school year school districts must work with parents, educators, students, and the community to develop a Learning Continuity and Attendance Plan (Learning Continuity Plan). The Learning Continuity Plan replaces the Local Control and Accountability Plan (LCAP) for the 2020–21 school year and provides school districts with the opportunity to describe how they are planning to provide a high-quality education, social-emotional supports, and nutrition to their students during the COVID-19 pandemic.



This chart provides a quick summary of how much New Day Academy plans to spend for planned actions and services in the Learning Continuity Plan for 2020-2021 and how much of the total is tied to increasing or improving services for high needs students.

New Day Academy plans to spend \$3,886,811 for the 2020-21 school year. Of that amount, \$523,335 is tied to actions/services in the Learning Continuity Plan and \$3,363,476 is not included in the Learning Continuity Plan. The budgeted expenditures that are not included in the Learning Continuity Plan will be used for the following:

Expenditures that are not included in the LCP are primarily operational costs that contribute to the school's overall function.

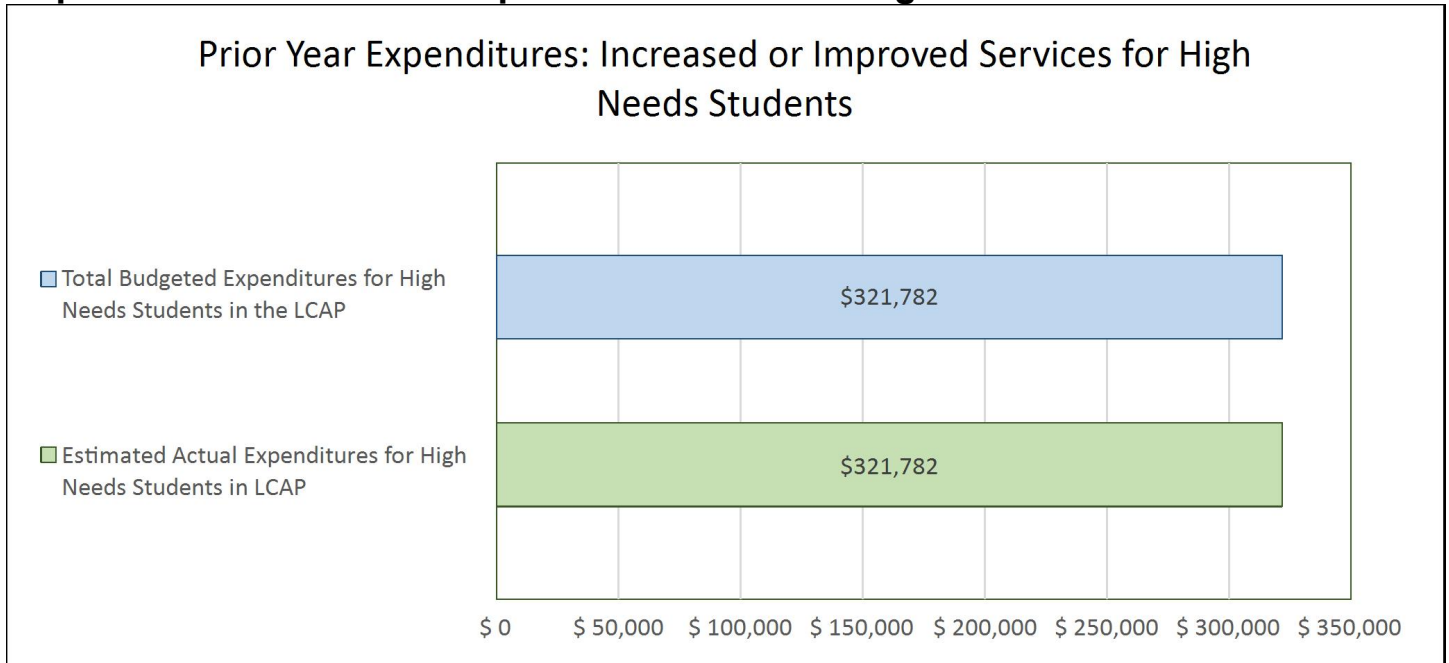
1. Administrative staff salaries;
2. Classified staff salaries;
4. Benefit costs of salaries such as PERS, STRS, Medical, Dental & Vision Insurance;
5. Instructional and general supplies such as paper, pencils, toner, mechanical parts, and other miscellaneous items;
6. Contracted services, liability insurance, travel and conference, communications, and utility costs.

Increased or Improved Services for High Needs Students in the Learning Continuity Plan for the 2020-2021 School Year

In 2020-21, New Day Academy is projecting it will receive \$294,029 based on the enrollment of foster youth, English learner, and low-income students. New Day Academy must describe how it intends to increase or improve services for high needs students in the Learning Continuity Plan. New Day Academy plans to spend \$523,335 towards meeting this requirement, as described in the Learning Continuity Plan.
